

# WEST COAST CARAVAN & CAMPER HIRE GERALDTON

CONDITIONS OF HIRE *Please read carefully before signing*

## I AGREE with each of the following conditions:-

- To return the camper trailer/caravan by the due date and time, and if the camper trailer/caravan is not returned on the due date and time, a daily rate of \$200.00 may be charged unless previously agreed by West Coast Caravan & Camper Hire Geraldton.
- That the camper trailer/caravan will be returned clean and in good working order. There will be a minimum charge of \$100 if not returned clean. The toilet must be returned empty and clean. If not a minimum charge of \$50 will apply. Cleaning and any repairs will be deducted from my bond.
- To keep tyres suitably inflated and if any are damaged I will pay the replacement cost of the tyres or puncture repair (if over 70% tread).
- To not overload the camper trailer/caravan beyond its limits.
- I will reimburse West Coast Caravan & Camper Hire Geraldton for any damage to the camper trailer/caravan caused by any water damage due to submersion.
- I will reimburse West Coast Caravan & Camper Hire Geraldton for any damage to canvas, zips, windows, floor, poles, pull out kitchen and any standard accessories hired with the camper trailer/caravan i.e. stove, gas bottle, water containers, mattresses, storage containers, or any other equipment hired separately to standard equipment, eg. solar panel, fridge or genset.
- There will be no refunds, partial or otherwise, and no future credit accrued as a result early return of the camper trailer/caravan, or any other hire equipment.
- All awning damage and replacement is at hirers expense. In windy conditions the awning must be rolled up.
- Destination must be as stated on the contract or we must be notified of any change and that change must be approved by us (WCCCHG). If vans or campers are taken down narrow tracks and dragged through trees, loss of bond will result.
- Nothing is to be placed loosely on the floor eg push bikes, BBQ, sharp items. Any damage will result in loss of bond.

## I understand that there is strictly NO SMOKING IN THE CAMPER/CARAVAN.

- I understand that the camper trailer/caravans are not to be taken off road unless agreed to by West Coast Caravan & Camper Hire Geraldton.
- I will comply with all relevant laws, regulations, rules and bylaws regarding the use of the off road camper trailer/caravan and pay any fees and charges incurred (including Road Closures, as driving on these may void any insurance).
- I will be responsible for all damage and injury, risk and liabilities:-
  - ▶ To the camper trailer/caravan or caused by the camper trailer/caravan.
  - ▶ To any person caused by the camper trailer/caravan.
  - ▶ To any property caused by the camper trailer/caravan.
- Lease fee and insurance paid is as per agreement with West Coast Caravan & Camper Hire Geraldton.
- I will notify West Coast Caravan & Camper Hire Geraldton of any developing fault/damage/breakdown or the event of an accident that may have involved the camper trailer/caravan. I acknowledge I am fully responsible for returning the camper trailer/caravan to West Coast Caravan & Camper Hire Geraldton including any transport costs incurred.
- I agree to pay a bond and I have been advised that the bond will be refunded to me (minus any deductions) within 10 days.
- I agree to pay the first \$1500.00 of any insurance claim for any damage to the camper trailer/caravan while on hire.
- By signing this contract I agree to all terms and conditions.
